Members of the public affairs department of the Morrow Junior Woman's Club are making final plans for a seminar on the Economic Status Of The Woman Alone set for June 1 at the Morrow Municipal Complex Community Room.

According to President Sanda Lager, "The seminar is being offered as a public service to the community.

Jane Young, chairman of the public affairs department of the Morrow Junior Woman's Club, said, "There is a real need for this type of seminar as many women are totally unprepared to face the world alone if they suddenly find themselves

widowed or divorced."

The seminar will feature four panelists who will address themselves to the problems encountered in the area of insurance, legislation, social security, credit, wills, estate planning and emotional adjustments. State Senator Virginia Shapard will be one of the panelists.

Mrs. Young stated, "The free seminar is open to the public and is expected to last approximately two hours."

A question and answer session will conclude the seminar.

Women alone

More than 70 women were on hand to learn about the economic status of women alone at a seminar on women alone sponsored by the Morrow Junior Club. The seminar was held at the Morrow Municipal Center Thursday night.

Panelists for the seminar were Rev. Tom Stubbs with the St. Augustine's Episcopal Church in Morrow; Mrs. Willis Horton, Kenneth Kilpatrick, president of the First Bank of Clayton County; Virginia Shapard, state senator from Clayton County and Rosemary Nicholson, representing the social security office.

"Your mothers didn't see the world you see before your eyes today," said the Rev. Stubbs. "There was no way they could have prepared you for it. You face an economic picture that was not even imagined in the years before 1900."

Rev. Stubbs explained that before 1900, women were not considered "respectable" if they worked outside the home.

"Until recently, women were just extensions of their husbands," said the minister. "We are only now beginning to treat women like people."

Rev. Stubbs suggested women alone become involved with loving, caring human beings, suggesting the church as a place to meet such people. "This is the best way I know to fight being alone."

The minister also suggested that one of the greatest values a woman could have would be vitality. "Vitality, a zest for living, is the greatest value in life," he said. "Back that up with a positive state of mind and you are ready to face anything."

Kilpatrick discussed wills, the need for women to establish credit in their own name, joint ownership of property and other money matters.

The bank president and lawyer stressed the need for a will. "There is no tougher problem than for a woman alone who has minor children and real estate holdings to die without having a will," said Kilpatrick.

"Even if your husband has a will, don't think you don't need one. There is always the possibility that he could die, leaving you everything, then you could die shortly afterwards leaving your children unprotected."

Kilpatrick also discussed joint ownership of property, pointing out a misconception many women have about joint ownership.

"At least 50 percent of the people I know believe that if property is jointly owned by the husband and the wife, if one of them dies all the property automatically goes to the survivor. This just isn't so."

Kilpatrick stated that this is possible, but the titles and papers have to be carefully

set up. "Again, I can't stress enough the need for a will."

The attorney and banker also urged women to establish credit. "Even if you are not a woman alone and don't intend to become one, it is not a bad idea to have some credit rating of your own."

"I realize of course that credit is hard to establish for women. But it is hard to establish for men, too," said Kilpatrick.

He suggested that women wanting to establish credit borrow some money and pay it back. "Just borrow some money, a small loan, and pay it back. Then you have established some credit," said Kilpatrick. "Borrow the money from someone you know if possible."

Rosemary Nicholson with the social security office in Clayton County explained some of the many ways social security benefits could help women alone. She explained benefits for widows and for women alone facing

retirement.

"But I can not stress enough that social security is not now and never was intended to be a complete retirement plan," said Mrs. Nicholson. "It is a supplemental income only, and women need to make other plans for their future, their retirement or other situations they may find themselves in. Social security will not replace totally anyone's income."

State Sen. Virginia Shapard discussed legislation in Georgia affecting women's economic status. She stated that women could have an impact on such legislation by letting their legislators know what they wanted and where they stood on such matters.

"The best time to contact legislators is before the legislature is in session," she said. "They then have time to discuss the matters with you. Also, if you prefer to write, don't use form letters. Personal letters show us that you are concerned enough to take the time to write, expressing your views in your own words."

The senator pointed out while poverty statistically is more prevalent among women, it is due basically because women hold low paying jobs with little chance for advancement.

"However, many women are not prepared for better jobs should the chance for advancement become available. I would suggest that the best investment women can make is to prepare yourself for better paying jobs," said Sen. Shapard.

"Take advantage of many state and federal programs which will allow you to go back to school to get the education, the preparation you need to get and hold a decent job with a future."

Sen. Shapard also stressed that women need to know more about their family finances.

"So many women have no idea about their finances."

They say, 'my husband handles that.' Well, that's fine if that is the way you both want it, but you need to be aware of the finances, the insurance, the debts, the investments, so you will at least know where you stand if it is ever dumped into your lap."

Willis Horton, who has been widowed for over four years, urged women to "get yourself a little smart."

Mrs. Horton stated that "It is an absolute fact. Women need to know. If you don't know something, go to an expert in that field and find out. Women were created to be looked up to, not down at. They were created to be looked out across at, as a peer. If you don't know something, find out."

Mrs. Horton stated that the most important thing a woman who suddenly finds herself alone can do is to get herself together emotionally. "You need to get to know who you are, what you are and where you are

emotionally. Once you get yourself together emotionally, you can handle anything else. If that means getting help, then get that help."

Mrs. Horton explained that a woman alone is simply a woman without a companion. "It does not mean you have to be isolated. Hold on to your friends, stay involved with people."

"One other thing, when you become a woman alone, either through death or divorce, never make any decisions under stress. Also, work through that grief."

Mrs. Horton stated that often the divorced woman faces more grief than the widow. "She is left just as alone, but she has to face the stress of rejection as well as being left alone. And often, she does not get the sympathy that a widow does."

"Work through that grief. If you don't, it doesn't go away. It will come back to cause you problems years later."

Women Alone:

Panelists Discuss Ways Women Can Cope With New Lifestyles

It was enough to make a grown woman blanch.

The 70 women gathered last week at the Morrow Community Room for the seminar on "The Economic Status of Women Alone" heard some startling statistics:

-Families headed by single women have grown ten times as fast as two-parent families in recent years.

Of women over 65, 2.3 million were living in poverty--compared to 1.1 million men in the same age group.

-A woman's median income in 1977 was \$8,000, 40 per cent less than her male counterpart.

-About 35 per cent of all female heads of households in 1975 were widows.

THE FIGURES were tossed out by State Sen. Virginia Shapard, but the four other panelists had some equally ominous warnings for women who depend on their husbands to take care of all financial matters.

In a word, their advice was: don't.

Besides Sen. Shapard, the panelists for the program, sponsored by the Morrow Junior Women's Club, were Rosemary Nicholson, director of the East Point Social Security office; Kenneth Kilpatrick, president of the First Bank of Clayton County; Willis Horton, a counselor at the Christian Counseling Services of Metro Atlanta; and The Rev. Thomas Stubbs, pastor of St. Augustine's Episcopal Church in Morrow.

THE PANELISTS all agreed on one thing: women today face financial and social situations their grandmothers could have never imagined. And part of the condition of women today is being alone, whether they plan on it or not.

"I never, never intended to be a widow," said Mrs. Horton, whose husband died five years ago. "But when you end up a widow, you have to be get a little smart."

Mrs. Horton added that of women married today, "at least half" will be widows before the end of their lives.

Kilpatrick had some practical advice for women who find themselves alone--whether single career

women trying to establish credit, or recently divorced or widowed women who have never had to manage a family's finances.

"PEOPLE ASK me all the time how a woman can get credit," he said. "I know there has been discrimination against women by lending institutions today, but from my experience in banking, a woman would follow the same procedure for establishing credit as anyone else. Find someone you know and can trust in a lending institution, borrow a little money, and pay it back. It's hard to establish credit, but then it's hard for everybody."

Above all, Kilpatrick stressed, all women--even happily married ones with young, healthy wage-earning husbands--should have a will.

He cited a hypothetical but all too possible case in which a husband died, leaving his estate to his wife, who is killed in a car accident two days later.

"WHERE DOES that leave her children?" he asked rhetorically, adding, "I don't know of a worse problem under state law to straighten out than when a woman who owns real estate, and who has minor children, dies without a will."

Mrs. Horton echoed Kilpatrick's advice.

"If you don't have a will of your own, the state will write one for you," she said. "But it sure won't be to your wishes."

The immediate cash needs of widowed women can often be taken care of under a law, unique to Georgia, called the "12-month Law," Kilpatrick said.

Under this law, a man's wife and minor children are entitled to receive enough money from his estate to live on for a year, superceding all other claims by creditors or beneficiaries.

AFTERWARDS, however, a woman is more or less on her own, he added.

That is becoming a common condition, said Mrs. Horton, who advised women today, no matter what their marital status, to "know who you are, where you are, and what you are now--before you are faced with a crisis."

While The Rev. Stubbs advised that a church is

often the best place for women faced with living alone to find new friends and enjoyments in life, Mrs. Horton told her audience to remember that being alone most often means being that

way "by choice."

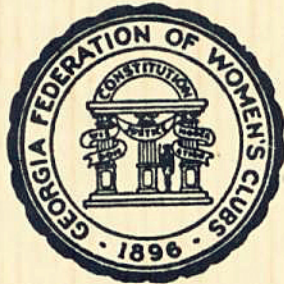
"Hold onto your friends," she said. "Never let yourself get isolated. And never be afraid to ask questions. I make mistakes only when I think I already know."

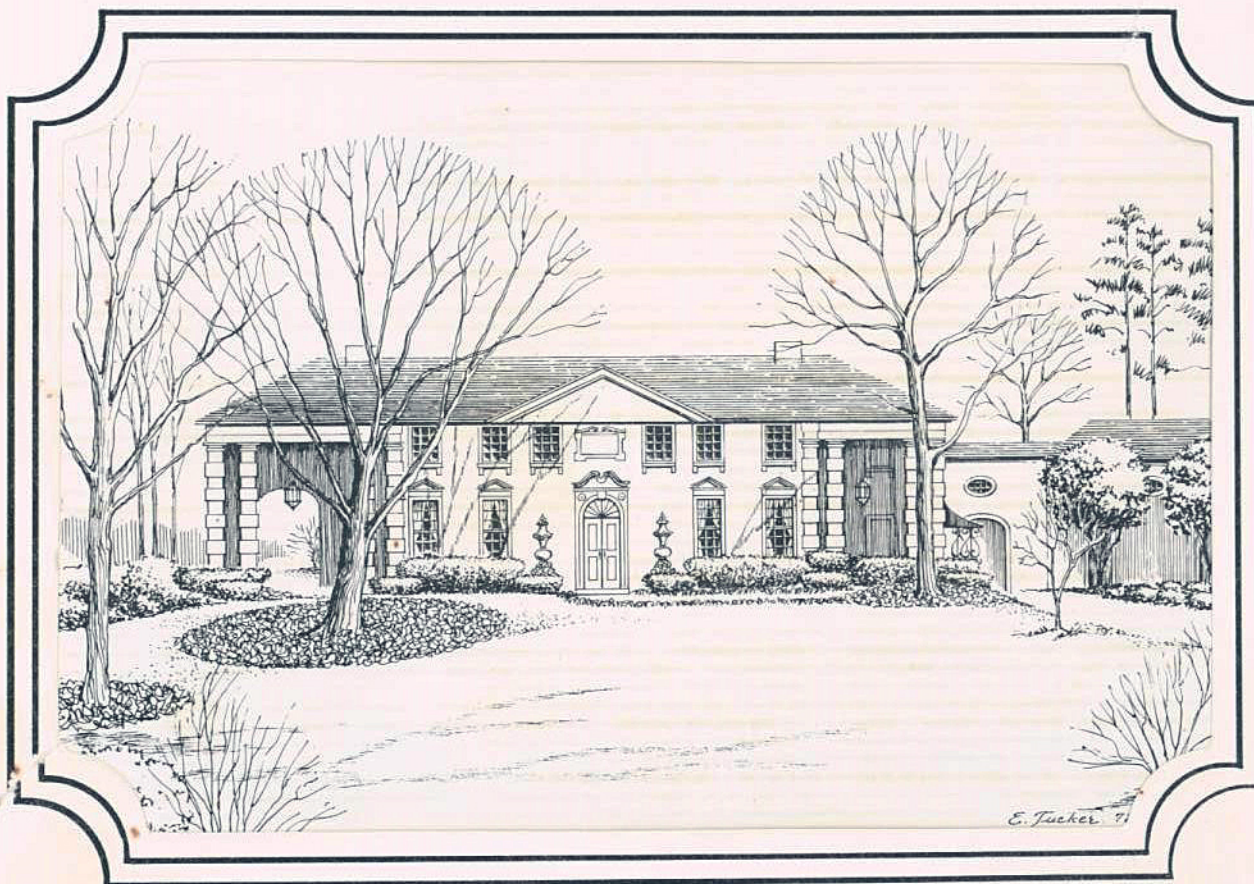

Library Changes Location

The Morrow branch of the Clayton County Library opened its doors today at its new location at 2266 Lake Harbin Road.

The day's festivities included an open house hosted by members of the Morrow Junior Woman's Club.

Clayton County Library Director Harold Krau explained that the old facilities located in the Maddox Plaza were intended as a "trial bloom" to see if the patronage would support it.

"The patronage was good enough to justify a larger area," he said. "In fact, it was good enough to warrant construction in this area, but the county doesn't have the money for such construction at the time."

"The Clayton County Commission decided to give us a larger space, renting it," he said.

Krau said the new facility will provide reference materials, records, art prints and additional books.

"We hope to expand even further and add audio-visual materials," he added.

"We couldn't even get additional books at the other location because of lack of shelf space," Krau commented. "We have about 600 additional square feet in the new location."

Krau said, "This is a stop-gap measure until such time when the county can afford to build a facility in the Rex-Morrow-Ellenwood area."

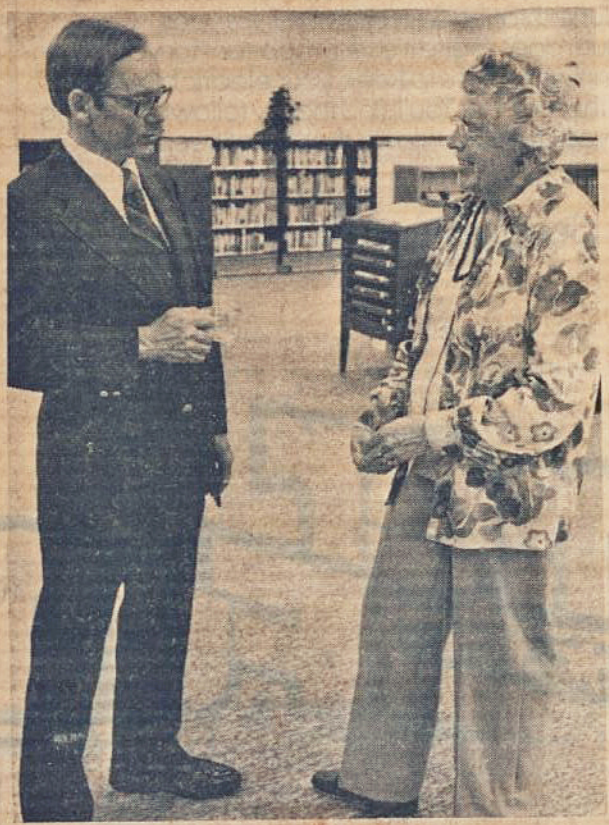



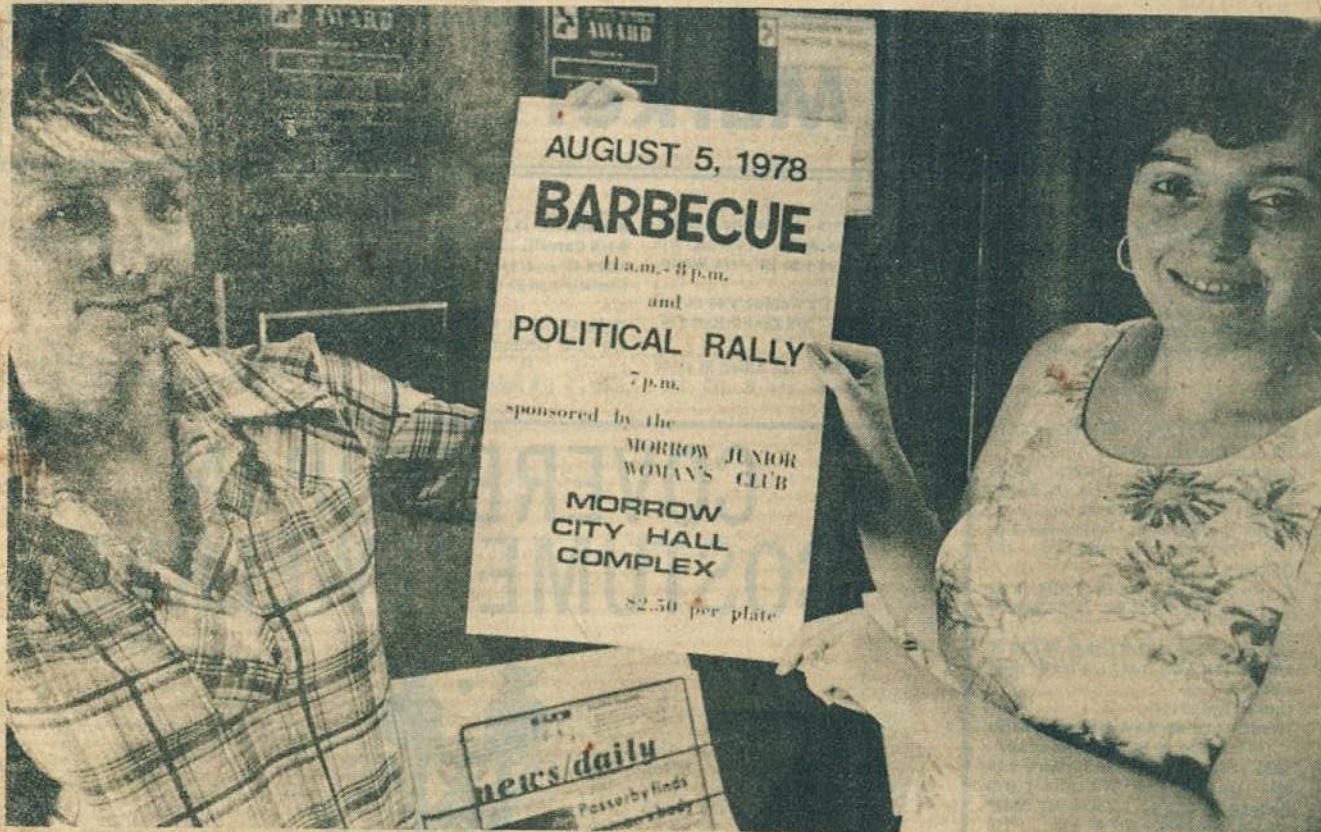

All political candidates for the Aug. 8 general primary elections have been invited to the event, both state and local, Mrs. Lager indicated.

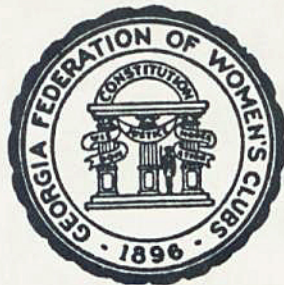
"This is the major fund-raising event for the club this year," she explained, "and all the money will be used for community projects."
