

Business In Review 1995: CSC's Annual Job Forum



Abortion Article Rebuttal: Staff Writer Speaks Out

I was astonished to read The Bent Tree article written by James Williams (March 27, 1995 edition, Vol. 26, Issue 11). His argument way off base, he even misspelled former Vice President Dan Quayle's last name ("Quale"). How is that for irony?

There is no excuse for the sorry content of his argument, either. References to "dogs that will latch onto your genitals" are mean-spirited, dumb, inane, unnecessary and totally uncalled for. Venting hate is not an argument. Mr. Williams claims to have a hard time understanding the "nasty" tone pro-lifers take. Ha! What hypocrisy! One does not have to look very far to find a nasty tone in Williams' editorial.

Trying to hide abortion behind a cloak of law is a transparent argument. Abortion was illegal for almost 200 years in this country, until January 22, 1973, when the Supreme Court handed down its Roe vs. Wade decision. Abortion is still illegal in the third trimester. Pro-life groups compare themselves to the Civil Rights movement of the 1960's, when blacks sought to overturn unfair voting laws. As Jesus responded, Beezebul doesn't cast himself out: "And if Satan cast out Satan, he is divided against himself; how shall then his kingdom stand?" (Matt. 12:26).

"[That was] the worst and most appalling statement I have ever read in The Bent Tree Dogs are the people . . . who write this stuff."

Williams says, "The GOP has never seriously attempted to have Roe vs. Wade reversed, it's just a bone they like to throw to those bloodthirsty dogs and blind Jesus freaks who actually believe this conservative bull-sh__." athy Bates and Jennifer Jason Leigh star in the latest big screen version of a Stephen King novel, *Dolores Claiborne*.

Bates, who won an Oscar for her role in *Misery*, plays Dolores. Leigh (*Single White Female*) plays her estranged daughter, Selena--a reporter for *Esquire* magazine.

In 1975, Dolores' abusive husband, Joe, was killed. Most of the people in the small Maine town, including Selena, believe Dolores to be guilty of the crime. However, Dolores was never indicted, and the death was ruled an accident.

As *Dolores Claiborne* begins, 18 years after Joe's death, Dolores is once again in the middle of what appears to be a murder. Her longtime employer, Vera Donovan (Judy Parfitt), is dead, and Dolores was seen standing over her body holding a rolling pin.

When she is arrested, her daughter Selena comes to try to help unravel the mystery surrounding her mother and the alleged murder (though how Selena manages is another story, considering her drinking and pill popping habits).

Throughout the movie, Dolores

tells Selena stories of a horrid past, which Selena has blocked from her memory. The stories, shown by a series of flashbacks, show Selena's father, Joe, to be an excessive drinker, guilty of physical, verbal, and sexual abuse.





Entertainment E-mail: Getting An Address And Living To Tell About It.

f you've been a student here at CSC for even a very short period of time, you've no doubt heard about the InterNet and electronicmail (e-mail) addresses. Feeling a little overwhelmed? OK, **very** overwhelmed? Does the mention of a computer make your skin crawl?

Let me make getting an e-mail address as painless as possible for you. During my first quarter here, I was told that as a member of the newspaper staff, I needed an e-mail address. I put it off for as long as possible out of my own "fear of the computer." Sounds like a topic for Oprah does it not, folks?: "Intelligent People Scared of Computers."

At any rate, I hope to make getting an e-mail address simple for you.

Let us start with where you need

Points area. Deann Cooper, located in the Urban Tribe shop, and Brian Skellie, of the Piercing Experience are two of the best around. They both are certified piercers and have sanitary establishments, keys to a good practice. They are also knowledgeable about the subject and welcome all inquiries.

Piercings run from \$40 to over \$100. This depends on the location and gauge of the ring. Just to give you something to go on, a tongue to go: Go to the library; you need to go downstairs. Look to your left and you will see a set of double doors. Go through them (you will not be trapped--the doors will let you back out).

You will probably see a lady at a desk. If you would like to be friendly, say "hi." You will want turn to the right and go down the hall next to her desk. Go into either of the first two doors and ... you have arrived!!! You are in the computer lab!

Pick any computer, sit down, relax. The power button is on the front of the computer; for the screen, it's at the bottom of the monitor. Turn both on. After a few tense moments, you will see a prompt that tells you to enter a login name. You will need to type "*getid*" (no spaces) and press enter.

The computer will ask you a series of questions to verify that you are a student (phone number, address, date of birth, social security number) and present you with a copy of an agreement (read this if you don't want to break any rules and make anyone angry).

piercing runs about \$45 (the ring is about \$20 and the piercing about \$25). Or, if you are really hard-core, you could just buy the ring and do it yourself. I did my first time.

By the way, piercers do not use **any** local anesthesia.

After you have been tagged, the next step is to properly care your new piercing--because infections are not fun. For piercings of the body, a diluted solution of Hibiclens applied Here is a hint for you: if the computer tells you that some part of your information was not valid--try substituting your work telephone number for your home number. In some cases this has fixed the problem.

After you have finished answering the series of questions, the computer will assign you an address. If your name is John Smith, for instance, your address might look something like this:

jsmi4q1@s1.peachnet.csc.edu

Okay, so it's not quite so simple as 123 Maple Street, but you will get accustomed to it. Write this address down. Also, write down your chosen password. *You will need it later*.

Now that you have gotten your address, you can turn that computer and monitor off and go back out through those double doors. When you leave the library, hold your head high, chin up. You have boldly gone where others have gone before. Be proud.

Be sure to check *The Bent Tree* next issue and I will tell you what you can do with your address now that you have it.

twice a day is recommended. For facial piercings, Bactine should be applied two to three times a day to the wound. Hibiclens is highly poisonous and should not be applied to facial piercings. And for oral piercings?-- Listerine and Gly-oxide should be used.

To speed up the healing process keep hands, hair, and tight clothing away from your piercing. Avoid drug use, excessive tugging and pulling, *—Pierce* continued on page 8—

and water activities like swimming. Another aid to the healing process would be to take 50mg of zinc three times a day with meals.

NOTE: you now have a direct line to your bloodstream. Refrain from oral or sexual contact until the piercing is well healed--and for genital piercings, use condoms to protect yourself from bacteria and viruses. Healing times range anywhere from 9 days to 9 months.

Hopefully, I have persuaded some of you to venture into the realm of body torture. It is really not as bad as you might believe. Even of you do get pierced, you can always change you mind and pull it out ... no commitments are required. So take a friend, get pierced today, and feel the pleasure. Oh, always remember that pain is only temporary!
