

#### There is a Virtue in Failure

# Wild Animals – Should they be "On Display?"

"But for the use of physical punishment by, and fear of, their oppressors, animals would never be a part of a circus." -Richard Pryor After 44 years and 30,000 performances as Siegfried & Roy, Roy Horn was attacked for the first time onstage. Remember the saying, "Play with fire, and sooner or later you will get burnt?" Well it appears Roy Horn finally got burned and is in critical condition. There are conflicting stories of why Montecore (white tiger) attacked Roy. Two reasons given for the attack were; a woman with large hair in the front row, freaked out the tiger, and after Roy fell Montecore was trying to protect him by dragging him off stage. Siegfried said if the tiger meant to kill him, he would have, immediately. On the way to the hospital Roy stressed Montecore was a good cat, and to keep him from harm.

Is this an isolated incident? Should animals be "taught" to perform unnatural acts? Will the animals eventually rebel against their trainer? Are animals in various circus acts treated humanely? Following are a few facts from the PAWS, Progressive Animal Welfare Society Website, Thunder Bay, Animal Misuse and Cok.net (Compassion over killing). "Numerous circus acts across Canada and the world continue to abuse and misuse animals in their

"performances". These animals are housed in small, confined cages for months or even years at a time and are beaten into submission. It is bad enough that we insist on using animals for testing of beauty products and scientific research but it is when we begin using innocent, wild animals for our own entertainment and the entertainment of our innocent children that we have gone too far. Animals such as lions, tigers, elephants and monkeys do not belong in acts, they belong in the wild."

"Baby animals are exploited from the day they are born. Newborns are prematurely removed from their mothers, which denies them proper nutrition and the natural socialization process required for normal development. Tigers, lions, and cougars are torn from their mothers

when they are just 5 days old and de-clawed at 2 weeks of age. Mothers spend weeks calling frantically for their missing babies. In the wild, tiger cubs stay with their mothers for three years." The AWA requires

that animal exhibitors be licensed with the USDA's Animal and Plant Heath Inspection Service

(APHIS), however, there are only about 85 APHIS inspectors to cover nearly 8,000 facilities nationwide.

Former animal trainer Pat Derby said, "after 25 years of observing and documenting circuses, I know there are no kind animal trainers."

Every year, approximately 35,000 bulls are tormented and killed in bullfights in Spain alone.

According to a 1993 University of Minnesota study, 840 horses were fatally injured on U.S. tracks in 1992, and 3,566 horses—or one horse in every 22 races—were so severely injured that they could not finish the race.

Former Ringling performer Kelly Tansy has this to say: On my very first day with the circus, I witnessed animal cruelty. I saw an elephant being beaten in what appeared to be a disciplinary action. The beating was so severe that the elepha screamed. I have come to realize, through all the circuses that I have worked for, that mistreatment of animals is a

> standard part of training and is thought to

be a "necessary" part of exhibiting them. As abuse to animals in circuses rises, so does the frequency at which they begin to fight back. In 1994, Tyke, an

African elephant, killed her trainer and

injured 13 others before police shot her to death. In January 1998, Arnold, a tiger performing with Ringling Bros., attacked his trainer during a publicity photo session in Florida. As the public watched, Arnold wrestled his trainer to the ground and bit him in the head. Workers using fire extinguishers and bullwhips forced Arnold and the other 11 tigers back in their cages. After Arnold had been returned to his cage (and therefore no longer posed a threat to anyone), his trainer returned with a 12-gauge shotgun and shot him five times, killing him. The USDA took no action against the trainer or Ringling Bros.

Incidents of animals lashing out at their trainers (especially elephants) are no longer uncommon. One police officer that had to kill a rampaging elephant states, "I think these elephants are trying to tell us that zoos and circuses are not what God created them for ... but we have not been listening."<sup>7</sup>

How do we change the misuse by these circuses? There are several ways to stand up for animal rights:

- Circuses will stop using animals when we stop giving them our money. Boycott all circuses and traveling acts that use animals. Instead, **support animal-free entertainment** like Cirque du Soleil, Circus Oz, the New Pickle Circus, and Cirque d'Hiver.
- Several communities have banned live animal acts in their area. Some include Quincy, Mass., Takoma Park, Md., and Hollywood, Fla.. Ask your city council to follow the path that these compassionate communities have blazed by creating an ordinance to outlaw animal acts.
- Write letters to local papers encouraging people to boycott abusive events. If such an event does come to your town, organize a demonstration and distribute this fact sheet to your neighbors and patrons of the event.

The new Intro to Film Class being offered at CCSU is for anyone who wants to know anything about films but were afraid to ask. This could be good or bad depending on what you like. The new class, in its first semester, is a roller coaster of knowledge. Taught by CCSU rookie Dr. Virginia Bonner, Intro to Film includes lectures and inclass screenings of selected films. It covers all the technical aspects of filmmaking including sound, mise-enscene, film style, camera work, and film genres. The class does have an awkward time frame. Generally it lasts for three hours on Tuesday which includes a 45 minute lecture, clip viewing, and a film screening. 
#### immune system as a whole.

Two second half goals lift #10 UNC Pembroke to 2-1 victory over Clayton State in men's soccer action Sat.

Morrow, GA — October 25, 2003 — The Clayton College & State University men's soccer team came 25 minutes from pulling off the Peach Belt Conference upset of the season Saturday before falling 2-1 to the 10<sup>th</sup> ranked University of North Carolina Pembroke Braves at Laker Field in Morrow, GA.

Leading 1-0 at the 65-minute mark, he Lakers surrendered two goals lown the stretch to fall to the Braves on homecoming. Freshman UNCP forward Trond Myrland (Molde, Norway) scored the game-winner in he 78<sup>th</sup> minute of the match, sliding a shot past the outstretched arms of reshman keeper Brian Jones Johannesburg, South Africa). The game-winner came off assists from unior midfielder Thomas Lindal Kristianssand, Norway) and freshman midfielder Barat Killian (Raleigh, NC).

Lindal tied the game at 1-1 at the 65<sup>th</sup> minute mark, drilling a shot from seven yards out past Jones after he nade a superb save only seconds earlier to deny a goal on a shot by sophomore midfielder Christoph Schiessl (Regensburg, Germany).

Lindal corralled the deflection and scored in the bottom right of the net.

Clayton State took an early lead in the match as freshman forward Pa'Alasan Jahumpa (London, England) converted a penalty kick at the 52minute mark after a foul in the box. The Lakers also had a penalty kick five minutes earlier on another foul in the box area but was unable to convert as senior UNCP keeper Alex Hall (Knightdale, NC) made a diving kick save to deny an attempt by junior Anthony Wright (Ashington, England).

The Braves finished the match with 2. shots compared to only seven for Clayton State. Jones played all 90 minutes for the Lakers and finished with five saves, while Hall had two saves.

With the win, the Lakers fall to 9-5-1 on the season and 2-3 in the Peach Belt Conference, while UNCP improves to 13-1 and 4-1 in the league. Clayton State will return to action on Saturday, November 1, traveling to play PBC opponent Francis Marion University. The Braves will return to action on Wednesday, hosting Wingate.

Nieto/Collantes win Alltel Fall Doubles Championship at GC&SU



MILLEDGEVILLE, GA — October 12, 2003 – The Clayton College & State University doubles team of Jackeline Nieto and Nathalia Collantes brought home top honors at the 11<sup>th</sup> Annual Alltel Fall Championships, which wrapped up Sunday at the Centennial Center Tennis Facility on the campus of Georgia College & State University in Milledgeville, GA.

Nieto and Collantes, both All-Americas in doubles last season, won the "A" Flight championship, defeating GC&SU's Luiza Biktyakova and Anna Shchupak 8-5 in the semifinals, followed by winning the championship by default Sunday after Brenau University's Lie Devries and Daniela Cavello conceded the match due to injury.

In the consolation draw, Clayton State's Collantes defeated GC&SU's Rachael Porsz 6-4; 6-3 to win the "A" bracket. Collantes fell to the consolation bracket after falling to Devries 6-0 and 6-0 on Saturday. She came back later Saturday to defeat the University of Tampa's Abby Shelide 6-1 and 6-1.

The Clayton State doubles team of Natalia Koulechova and Elizabeth Syrova fell in the "B" Flight doubles championship Sunday to Brenau's Eva Demasova and Helen Macchi 8-5. The duo of Koulechova and Syrova opened the tournament with an 8-0 victory over ABAC's Shermona Culmer and Amanda Cumbess, followed by defeating Otavia Bastos and Dominique of USC Aiken 8-2 in the semifinals.

2003 — Katie Stokes scored an early first half goal, and that's all the University of North Carolina Pembroke women's soccer team needed on Saturday en route to a 2-0 Peach Belt Conference victory against Clayton College & State University at Laker Field in Morrow, GA.

Sophomore forward Stokes (Charles Fown, WV) scored the game-winner n the 17<sup>th</sup> minute of the match off an assist from freshman forward Lefke Boysen (Bremen, Germany). Stokes scored the goal on a header from short range after freshman keeper, Judith Chime (Enugu, Nigeria) deflected a shot by Boysen. After nearly 55 minutes of scoreless play, the Braves added a little insurance in the  $72^{nd}$  minute as junior midfielder Simonae Taylor (Jacksonville, NC) scored on a shot from six yards out after a cross from Boysen, her second assist of the match.

The Braves controlled much of the match and had 29 shots, compared to only eight for the Lakers. Chime finished with 15 saves, while freshman keeper Hillary Helms (Nashville, NC) finished with four saves.

With the loss, the Lakers drop to 3-12-1 on the season and 1-5 in the league, while UNCP improves to 10-4 and 3-3 in the conference.

She defeated USCA's Nicole Coope 6-1 and 6-4 in the quarterfinals and UNCP's Abi French 6-2 and 6-0 in the second round. Syrova also advanced to the "B" Flight semifinals before falling to GC&SU's Chenelle Kruger 6-2 and 6-3. She won 6-1 and 7-5 in the quarterfinals over Tampa's Paula Fillion and 6-2 and 6-0 in the second round over USCA's Bastos.



#### **Cooking With G'Licious**

#### **D-BO'S STROGNOFF**

1 lb of hamburger or Turkey
1 onion (diced)
1 green pepper (diced)
1 can of cream of mushroom soup
4 ounces of sour cream
1 clove of garlic (crushed)
1 bag of egg noodles
Salt, pepper and other seasoning: depending on the cook!

To begin this meal, start with a pot of water. Bring water to a boil then add the noodles. While the noodles are cooking\*, start browning the meat. Keep your eye on your noodles—stirring noodles helps prevents sticking/clumping of the noodles. Noodles should not be completely cooked. Rinse the noodles and place in cold water until it is time to put them in later.

Now back to the meat.... After the meat browns, drain it. Add diced onions, diced green peppers, crushed garlic, salt, pepper and any other seasonings you desire. Cook for about 5 minutes so that everything blends in well. Add the cream of mushroom soup with half a can of hot water. Cook uncovered for 10 minutes and serve.

**REMINDER:** This recipe is to my taste. If you are a lover of sour cream, use more. If you do not cook with salt, do not add salt. It will not alter the meal much (if any). Experiment with things in the kitchen. You never know what things you may create. One last suggestion, this meal is for 3-4 people. If you are the only one eating, cut your ingredients.

#### **The Boundaries of Magic**

note that simply reads "Thank AYou" rests upon the London hospital bed of David Blaine after treatment last week. He was under surveillance after losing 56 pounds over a six-week period. A few days prior to his departure from the hospital, he was gradually worked up to digesting solid foods again after his organs had been atrophied from this 44-day amount of starvation. Was he trapped in a mineshaft or kidnapped and locked in a closet by a dangerous criminal? No. David Blaine had willingly locked himself into a glass box without food over the city of London next to the tower bridge - to

However, he might not have been glorified to such a level if the danger had not caught up with him. His body's resistance to the stunts finally stopped resisting as he suffered from intestinal and organ pain due to his constant constriction and the abuse that he implemented on his body. Before a performance, a student punched him in the stomach, which possibly worsened the pains he was enduring through his appendicitis. He did not cancel his performance, however. Houdini passed out and died during his performance shortly after.

David Blaine parallels himself with Houdini in his defying, dangerous stunts. Blaine has said that he has wanted to bring magic "to a level where Houdini had it a hundred years ago". He has accomplished this through his style of street magic and crowd awareness. Blaine uses techniques of conducting magic that can appeal to just about everyone. In his special David Blaine: Street Magic on The Learning Channel (TLC), he performs tricks through cities and less-privileged neighborhood streets with cards and simple props, such as strings and coins. However, his publicity has geared around his dangerous stunts, such as his Ice Box act where we was locked in a frigid ice coffin for 62 hours, and his Vertigo act, where Blaine stood erect above a park in Manhattan for 35 hours on a thin, eighty-foot-high pillar that supported a 22 inch platform for him to stand upon. His latest stunt, the

Redd's Classy Citrus Ice-Cream Ingredients:-1 Sweet Orange 2 Limes 1 Pint (500ml) Heavy Whipping Cream 3/4c + 1 Tablespoon Powdered Sugar Tupperware container with lid

Grate the zest of the orange and one of the limes in a bowl. By the zest I mean just the colored part of the fruit, not the white pith. Juice both limes and the orange into the bowl, then stir in the powdered sugar. Stir to dissolve and then add the cream. Now for a little whipping! If you don't have a whisk, you can just use a fork, but you want to whisk this pretty vigorously. You are waiting for the cream to get stiffer, so that it makes soft peaks when you stop whisking it. This usually takes five to ten minutes if you are doing it by hand. When it is peaky, pour it into the Tupperware container and place in the freezer. This needs about forty minutes to freeze, and will keep for three days or so. If you let it freeze completely, take it out for about twenty minutes before serving so that it softens. London box stunt, truly mirrors the danger of Houdini's acts of suspension and confinement, especially since he was locked in a glass box, much like his predecessor's final outrageous stunt inside the water chamber.

For years, the world of magic has become placid and monotonous, which is what fuels David Blaine's desire to conduct his unique style of performance. Magical extravaganzas have been well practiced and constructed through the Las Vegas acts of David Copperfield, the Pendragon family and Lance Burton. Grand costumes, intense music and an alluring stage presence involving beautiful women and exotic animals dramatize the majestic nature of the performers. Through their attempted "dangerous" stunts, this entertainment has been labeled and dissected by the desensitized audience as fake. However, the stunts of these performers had been lowered in interest over consistent years, due to their repetitious and uninventive nature. As bold and artificial as they have supposedly become, they are still alluring and wonderful to view, which still sparks the interest of seeing these shows in Las Vegas. However, the danger of the world of magic has stricken this genre as well. Recently, the well-known performing duo of Siegfried and Roy were performing their consistently dazzling routine involving magic and beautiful white tigers. During their performance, one of their tigers grew enraged and attacked Roy, mauling him and delivering a brutal blow to the throat of the magician. The fifty-nine year

old magician survived, yet remained in critical condition for 7 days. While the show has been cancelled at the Mirage in Las Vegas, Roy's partner Siegfried delivered a message of hope that states his and his partner's interest in their pursuit towards animal conservation, even though it is questionable whether Roy will ever perform again.

Illusion and magic have real aspects, as we discover from Houdini's death, Roy's white tiger attack and the dramatic effects of David Blaine's marvelous stunts. This realism keeps an industry grounded that could soar above the clouds if it wasn't made aware of the risks. As citizens who are consistently grounded through our work and diligence of survival and staying grounded, a little magic in this world can be an asset. However, from this realism of the magic that exists in every day people, David Blaine teaches and learns, all at the same time. In that box above London, David was enclosed and lonely for forty-four straight days hovering above a crowd of spectators that watch him conduct his feat. He survived on water and water alone that invoked a hunger that ached his stomach and caused his body to burn off most of it's fat content. Why would someone want to do this to him or herself? He further learned about himself and what boundaries that he as a person can push, while his audience is taught that same lesson through his acts - that people have the magical abilities to endure hardships.

It is this danger revolving around an act, the possibility of someone being hurt yet not wanting them to be hurt, that draws us to watch these performers that mystify us. This sense of danger is not a new concept; dangerous acts have been mystifying us for a long time. During the start of the twentieth century, Harry Houdini rose to fame by his stunts involving straight jackets, bathing in tubs of ice water and escaping from scenarios where he was bound with ropes and handcuffs.

Grocery store sales bins (you'd be amazed!)




#### In My Experience: Working on Campus By Ashley Spillers

A quick search of the Web will reveal the history of the Pledge of Allegiance. It appeared in 1892 in a children's magazine whose editors and publishers were interested in promoting patriotism in schools. A quarter century later it began to be used in public gatherings. In 1954, President Eisenhower encouraged the inclusion of the words "under God" into the pledge. Recently a lawsuit demanded that a public school refrain from requiring children to recite these words on the grounds that they violate the First Amendment requirement that the government refrain from establishing any religion. Here are my thoughts on the issue. If "under God" is retained in the pledge, there are two possibilities: Perhaps the reference is to a specific God and therefore, to a specific religion. For any government agency to require recitation of this statement of belief in a given religion would clearly contradict the meaning of the First Amendment. Alternatively, the reference is to a

vague notion of God, according to whatever religion the speaker cares to have in mind. This is too theologically sloppy to merit serious consideration. A vague reference to some nonspecific deity trivializes all religion. Furthermore, both positions disregard the views of American citizens who do not believe in a specific concept of God.

Restoring the Pledge to its original form—a statement of respect for a national symbol and for the nation itself—would honor the highest principles upon which the United States is founded, freedom of thought and belief. Individuals who wished to add "God bless America" could do so, without using the power of the government to put this sentiment in the mouths of those who do not wish to express it.

Getting back to the original purpose of the Pledge, which was to foster patriotism in children, it probably would be more useful to ask school children to recite the Preamble to the Constitution, or the First Amendment itself. the 50 year foundation should not be removed. It is not cracked nor broken, and for those who may oppose we should all respect their opinion, however it important to know that we honor the U.S. flag therefore, these are words that are associated with it and they are the words that our Nation is groomed to pledge. Our Nation is Under God!




