Mission to Mars:

Spirit and Opportunity Begin Their Journey By Shea Haley

Picture it. You have traveled for nearly seven months and have landed safely on an uncharted planet in search of one thing. You step out onto Gusev Crater; your landing site. You shield your eyes from the reddish reflection off the hills in the distance. With no idea of what to expect, you are greeted with late summer ground temperatures of forty-four degrees Fahrenheit. The air above you is a chilling twelve to fifteen degrees. If you had arrived just a few months later, autumn would have welcomed you to one hundred and twenty three degrees below zero. Thanks to the Rovers, we can just sit back and cheer them on. With names picked by a third grader in an essay contest, Spirit and Opportunity and trekking across Mars with four objectives:

- To determine whether life ever arose
- Characterize the climate
- Study the Geology
- Prepare for exploration

Equipped with complex but powerful tools, both Rovers are able to get up close with soil and rocks, which are, believe to house what liquid water remains. On the south pole of Mars, an ice cap is buried below many sheets of "dry ice" that has never given way to the water it's protecting. Scientists hope that by studying the rocks with high powered magnifying glasses, they will be able to shed some light on the question we have all been asking; was there life on

The mission should last until the end of April (depending on how the Rovers hold up). NASA experienced their first glitch early on in the mission. Spirit's communication with ground control had failed. With Opportunity landing soon and on

the other side of the planet, NASA wondered if Spirit could be fixed, or if it would become another expensive piece of space junk. In several attempts to communicate with Spirit, NASA finally made contact. "We don't know yet whether Spirit will be perfect again. Our current theory is one in which software would fix the problem," Jennifer Trosper, Mission Manager explained. It was determined that the flash memory in Spirit became overloaded and could not manage the information stored. (Flash memory is used in digital cameras for those who are not camera savvy such as myself.) However, controllers are hopeful that they can begin deleting some of the files that seem to have bogged Spirit down. So far (and knock on wood), Opportunity has not experienced any kind of mechanical failure. Being Spirit's twin, one must wonder if NASA is taking proper precautions to make sure that the overload does not occur in Opportunity as well.

Covering yards of terrain a day, Spirit and Opportunity are exploring and sending necessary information that is proving beneficial about the now dry lakebeds. After a ten-year dream, millions of dollars and the President's backing, the outlandish thought of actually inhabiting Mars is finally being considered. With no rain in the foreseeable forecast and "dust devils" (dust storms that pack more of a punch than our tornadoes) threatening at any time, Spirit and Opportunity definitely have their work cut out for them, without the help of little







Eyes on the Road

Every single person who gets behind the wheel of a car can help to eliminate over a million accidents that occur each year. How? They can accomplish this by paying attention to the road. It's that simple.

There is an enormous host of distractions that can impair ones abilities to drive. Nearly every single person that has manned the driver's side of an automobile has employed one of these acts. A multitude of things can distract the driver. The most common impairment that has become a staple of popular culture is the usage of cellular phones while behind the wheel. I'm not sure how many people have thought this, but every time that I have seen a car veer close to my lane of the road and the driver is holding a cell phone, I politely scream in my head "Get off the phone!" Of course, I should be thankful that I am not one of the four thousand, three hundred (4,300) accidents that occur daily due to distractions, as observed at the California Department of Motor Vehicles.

This figure includes drivers that use cell phones while they drive, but is also comprised of those drivers who are attending to children and eating a rushed meal. At times, it may seem impossible to get somewhere on time while stopping the car in order to hand your child a juice box in the

backseat. Even if this seems unworkable, drivers have the ability to wait until they have come to a safe stop in order to do these things. While on the highway, NONE of these activities should even be considered. Accidents due to distraction can also occur in relatively harmless activities, such as radio/CD player selections and the effect of a clever billboard. The small timeframe in which a person is glancing down at their CD collection could be the split second that another person swerves over due to their own distracted state while unwrapping a cheeseburger. The truth is that if you take your eyes off the road or falter your concentration for a split second, any collection of surprises can leap out.

In order to prevent any unsightly actions from occurring, certain safety precautions should be exercised. For one, get off the phone. When a person gets on the phone while driving, their risk of having an

accident raises by 400 percent. It is extremely dangerous to both hold onto a cell phone and the steering wheel as well as try to pay attention to a conversation that must be horribly important since the person is driving and talking at the same time. Cellular phone headsets that plug into jacks onto the phone have probably lowered the occurrence of these accidents. This invention frees up both hands so that the driver can safely operate the vehicle. However, the driver can still be distracted from the road by the conversation. If you must make phone calls, try and make them brief or exit off the road and talk.

Second, have certain items ready and accessible in the car for your children. Like I said for the person glancing at the CD collection, just imagine if the driver is turned towards their children. That is an extremely scary thought

which can be avoided if the parent can have certain things ready to hand them at a moment's notice. Better than that, the parent can wait until the car is stopped. Also, always have your children safely buckled up in their seat in order to prevent the possibility of their movement. Give them a distraction, such as a toy or a game, so that you can safely navigate to your destination without too much guff from the peanut gallery in the backseat.

Third, don't let modern small distractions pull your attention away from the road. Always wait until you are at a stoplight in order to change your music. Plain common sense should tell the driver not to glance at the CDs while attempting to drive. Also, don't fall under the whims of small print billboards. If you can't read the writing in a swift glance, DON'T. Both of these things not only aren't necessary in order to get from point A and point B, but also are crafted for the sole purpose of stealing your attention away from other activities. Only partake in these indulgences while stopped.

Drivers should always remember to buckle up, keep your eyes on the road, and concentrate wholly on what you are doing while driving. There are other people driving on the road other than the one behind the wheel, and all drivers' lives are in each other's hands. Please, for everybody's sake, exercise safety. Oh, and get off the phone.

Lost in Translation has recently received the label as the best Comedy/Musical movie of the year, thanks to the Hollywood Foreign Press' Golden Globes. How to Save Your Own Life (or that of a friend)

In the fourth Star Trek movie, The Voyage Home, Spock was asked by a computer, "How do you feel?" Take a moment and ask yourself the same question. How do you feel? Up? Down? Stressed? Now think about your friends, companions, and family members. How do you think they feel?

Did any alarm bells sound? Is there someone you are concerned about? Do you care either way?

We hear about suicides, suicide pacts, and depression on the news, but do we ever make the real connection between them? Many people call suicide a totally selfish act. What if it is a symptom of a serious disease? How do we identify the signs that something is wrong with ourselves or with our friends?

First of all, I want to put aside the notion that depression is simply feeling sorry for oneself. In some cases this might be true. Selfish people do exist. Grief, disappointment, and other stressful things common to the human race cause situational depression. This kind of depression is normal and will run its course naturally. Clinical depression is not the same thing. In some cases it will run its course, but in this stressful society, most people suffering from clinical depression need medication in order to combat the disease.

According to the experts, the symptoms of clinical depression are:

- A persistent sad, anxious or "empty" mood
- Sleeping too little or sleeping too much
- Reduced appetite and weight loss, or increased appetite and weight gain
- Loss of interest or pleasure in activities once enjoyed
- · Restlessness or irritability
- Persistent physical symptoms that don't respond to treatment [such as headaches, chronic

pain, or constipation and other digestive disorders]

- Difficulty concentrating, remembering, or making decisions
- · Fatigue or loss of energy
- Feeling guilty, hopeless or worthless

Thoughts of death or suicideThe last symptom is the most alarming. It has happened to me, despite my faith, my family, and my love for life. Only because I was aware of the symptoms of clinical depression was I able to get the help I needed to save my life. Later on I recognized the symptoms in a family member and got him help, too. In our cases, a visit to our family doctor got us on our way to relief. Sometimes it requires a trip to the emergency room, and in some cases a short visit to a psychiatric hospital. If it saves a life, it is worth it.

There are so many medications now that treat clinical depression. The medications literally save lives. Yes, they are occasionally prescribed to people who don't need them, but this should not create a stigma for those who NEED the medication in order to lead a productive life, or to lead any kind of life at all.

Do you know someone who is exhibiting the symptoms of depression? Is your friend's face downcast most of the time? Does he or she not laugh the way they used to, or are they now taking life way too seriously, or not caring about anything at all? Ask them how they feel. Be bold enough to talk about whether or not they are thinking of doing harm to themselves. If they mention suicide in passing, take it seriously. What comes out of our mouths is normally what is in our hearts, and if someone mentions wanting to end it all, it is better to make a big deal out of what may be nothing than lose a friend and regret your maction for the rest of your life. Care enough to get them help. Go to the doctor with them. Offer them a ride to the emergency room, and above all, if YOU are exhibiting the signs of depression, get help for yourself.

Trim Up While Eating Out

Let's face it: nutrition stinks. Plain and simple, the correlation between taste and nutritional value is usually a negative one. Everything that tastes great will normally expand something on a person's body two or three inches, without hesitation. This fact gets even worse when someone is in a rush, and the only options to choose from are fried chicken, fried potatoes, or fried beans in a soft tortilla shell. America has become the nation of the "Hamburger, French fries and Coca Cola" meal, as well as the nation with a weight problem. Coincidence? You wish. However, there is a way to balance the need for a quick meal, nutritional benefits, and social gatherings at restaurants.

Calories are the body's most trusted ally, as well as one of its most trusted enemies. They are the source of energy that our body thrives off in order to fuel us with energy each and every day. On average, the human body needs somewhere around one thousand, five hundred calories (1500) to two thousand, two hundred (2200) calories, which depends on your body size. However, a safe figure to live by is two thousand (2000) calories. Anything over this amount is stored as fat inside the body. In order to limit the fat stored, you can monitor your food intake by the number of calories you consume in a day. You know the nutrition labels on the back of those Cheetos you ate with lunch? That's where you can see the nutrition content (i.e. calories, vitamins, minerals, etc.) Another thing to watch when you eat is the fat content within your food. Fat is quickly stored as, well, fat. Enough said. It is practically impossible to have zero fat in your meals, but if you are trying to watch what you eat, lower fat content is better. The same goes for the sugar in sodas and desserts. It is stored as fat rapidly as well, after it is absorbed into the blood stream.

The calorie and fat content in fast food is pretty close to being dreadful. Grease, sauces, and all kinds of fried everything cause a dizzying array of things to choose from – or between for that matter. However, it is possible to curb some of the unhealthiness at fast food restaurants, while still enjoying some great tasting food. There are three simple guidelines that one can utilize in order to trim up their meals. For

starters, restaurants love to sell their customers larger portions of their "gourmet delicacies". McDonald's loves to "Super-size" things, Wendy's asks if the customer would like a "Biggie-sized" fries and cola, and Taco Bell loads you down with nacho cheese, if desired. If weight and nutrition is a concern, just say no to larger portions. Get smaller portions and limit the fat and sugar from the fries and cola. Second, sauces are nothing but taste enhancers. Remember, sacrificing some taste for a meal that still tastes good is a beautiful thing. Cut out the mayo and other dunking sauces to cut out even more calories and sugar. Furthermore, there are higher and lower calorie salad dressings, depending on your taste preferences and desire for health. Third, fried foods equal high fat content. High fat content equals to high calories and rapid fat storage. In order to limit this storage of fat, cut out the amount of deep-fried items. Side salads are great alternatives to fries. All fairly simple things, but what exactly can someone purchase at these restaurants that taste good and stay nutritionally fit? What can you do if you want something vegetable-based? Let's take a look at the options. There are some more nutritionally sound items on the menus; however the items selected are of reasonably large size to satisfy a normal hunger.

Either green chilies or Taco Bell fire sauce

Open the can of refried beans and put into a pan. Turn on to a medium heat and stir until melted. Cut the Velveeta into small chunks and add slowly to the beans, mixing well until the consistency is smooth. If you don't like spicy food, stop here. If you do, you can add finely chopped green chilies to taste, or about three packets of Taco Bell fire sauce. With this deep, you can continue adding cheese to taste, it's really just a good base with a lot of potential. Enjoy!

Rice and Hamburger Wraps

Ingredients:

1/2 lb. lean ground beef
1 (10-oz.) pkg. Green Giant® Frozen Rice
Medley with Peas and Mushrooms
1/8 teaspoon pepper
2 (10-inch) flour tortillas, heated
2oz. (1/2 cup) shredded Cheddar cheese

Preparation Directions:

1. Brown ground beef in medium nonstick skillet over medium-high heat until thoroughly cooked, stirring frequently. Drain.

2. Add frozen rice mixture and pepper. Reduce heat to medium-low; cover and cook 8 to 10 minutes or until rice and vegetables are tender, stirring occasionally to break apart rice and vegetables.

3. Spoon about 1 cup mixture down center of each warm tortilla. Top with cheese. Fold up bottom of each tortilla; fold in sides. If desired, enclose bottoms of wraps in foil.

Ideology holds the reins

Greg Hampikian is an associate professor of biology here at Clayton College and State University.

As a geneticist, I know that censoring scientific speech is a bad idea. One historical example may help illustrate this point. In the early 1900s Russia had a solid reputation in the biological sciences, including two Nobel prizes in medicine.Genetics was then a new field, and many young scientists were drawn to study it.Since Russia was the largest agricultural producer in Europe, Russian science was expected to make great improvements in food production by using genetic research to breed new strains of wheat and other foodstuffs.But when Stalin came to power in the 1920s, he decided that the concept of the gene conflicted with aspects of his ideology, Marxism. The

official view was that genes were a capitalist invention and did not really exist. At first, Lenin did not forbid use of the word "gene," but it was dropped from the textbooks. After a while, researchers who insisted on using the word lost their government funding and thus their positions. Within a few years, genetic research was completely arrested in Russia by a political program that promoted scientists based on ideology. Russian genetics made no progress for 30 years, until Stalin's death in 1954. It was another two decades before Russian education was freed from his ideological constraints.Scientific principles are not subject to the whims of politicians or voters, but scientific progress

is. The truth can't be changed by those in power, but the curriculum can be.Let's be honest. Whoever proposed removing the word "evolution" from the Georgia curriculum was not objecting to a word but to a scientific principle, and they were not acting based on scientific knowledge, but rather on personal ideology.Replacing the established scientific term "evolution" with the doublespeak gibberish "biological changes over time" is classic politburo. I am not just a scientist in this state, but a parent who voluntarily substitute teaches and a Christian who directs a student ministry group. In all of these roles I am affronted by the new draft curriculum.
